

WEDDING ENTERTAINMENT SERVICES AGREEMENT 2009

This agreement, dated _____, is made by and between "the Customer" (Bride's name) _____, whose address is _____ phone number, _____, and e-mail, _____.

1. Entertainment Services. The Customer hereby employs the Contractor to perform the following services in accordance with the terms and conditions set forth in this agreement. The Contractor will provide musical entertainment consisting of

The Contractor's work will be performed in a commercially reasonable manner according to the stated wishes of the Customer. Note: Travel is free if the destination is less than 25 miles away. **A travel fee of \$25 per musician is applied if the destination is 25-50 miles away. A travel fee of \$50 per musician is applied if the destination is more than 50 miles away. We use MapQuest to figure distances and our starting point is the main USPS office at 850 Twin Rivers Drive Columbus, OH 43216.**

2. Payment to Contractor. The Customer agrees to pay the Contractor \$_____ for the services provided. The Customer also agrees to pay a **\$100 non-refundable deposit**, which will be applied towards final payment, receipt of which is acknowledged by the Contractor upon the execution of this agreement. This deposit is non-refundable in that it covers booking and other administrative expenses and is intended to partially compensate the Contractor in the event of a cancellation. If the wedding ceremony exceeds an hour, there will be an additional charge of \$75 for each thirty minute increment over the contracted time for the duo, and \$100 for each thirty minute increment for the quartet. Catholic weddings with a full mass should plan on booking an hour and a half. **The Customer agrees to pay the Contractor's bill in full seven (7) business days prior to the event. Contractor has the right to cancel services if final payment is not recieved. _____(inital)**

3. Cancellation. Either party may cancel this agreement by giving 30 days advance notice to the other. Notice to the Customer shall be given to (name & phone #)_____. Notice to the Contractor shall be given to **Gail Stadelman (614) 457-5854**. In the event of a timely cancellation by the Customer, the Contractor will refund any money paid by the Customer to the Contractor other than the \$100 non-refundable deposit. In the event that the contractor is unable to perform due to injury, or extreme illness, then every effort will be made to find alternative musicians in order to fulfill the said agreement, or refund all monies paid.

4. Excused Performance. If the Contractor is unable to perform under this agreement due to circumstances beyond the Contractor's control, such as fire, flood, blizzard, other

Act of God, military action, war, insurrection, riot, strike, civil disturbance, or travel restrictions imposed by a governmental authority, the Contractor will be released from any and all liability under this agreement

***For all outdoor events please note that direct sunlight will damage our instruments, and therefore some type of shade must be provided. Also, if severe temperatures(above 95F or below65F), in the Contractor's reasonable judgment, would damage our instruments if used outdoors, the Customer must provide alternate indoor arrangements. If no alternate indoor arrangements are made, the Contractor will be released from any and all liability under this agreement.**

5. Independent Contractor. Both the Customer and the Contractor agree that the Contractor is an independent contractor in the performance of its duties under this agreement. Accordingly, the Contractor shall be responsible for payment of all taxes, including Federal, State and local taxes, arising out of the Contractor's work under this Contract and shall maintain insurance to cover the risk of loss to Contractor's person or property.

WEDDING PACKAGES PRICE LIST

Silver Package \$325

Our most popular package, featuring the well known Fiddles & Faces Duo . This package includes a full one hour of music starting with thirty minutes of Prelude, the Processional, Recessional, any special requests during the ceremony, and Postlude. This is a great choice for those who want the full, rich sound of two violins. If your ceremony is longer than an hour, there is an additional charge of \$75 for each thirty (30) minute increment over the contracted time for the duo, and \$100 for each thirty(30) minute increment for the quartet. Catholic weddings with a full mass should plan on booking an hour and a half.

Gold Package \$475

Our two hour package. It is the same as the Silver Package with the Fiddles & Faces Duo, plus an additional hour of cocktail/reception music following the ceremony.

Platinum \$625

Our three hour package. It is the same as the Silver Package with the Fiddles & Faces Duo, but with an additional two hours of reception/dinner music. This is a wonderful package if you want elegant music, rather than a D.J., for your reception or dinner.

Note: The Fiddles & Faces String Quartet follows the same packaging and services, with the Silver Package at \$525, the Gold Package at \$725, and the Platinum Package at \$925.

All Packages are Inclusive

- * A personal music consultation to help you find the right music for your special day. We also talk about the timing and the flow of the wedding, so that we typically don't need to be at your rehearsal run through.
- * A free one hour skin care analysis and makeup consultation. This is good for up to a year from the wedding date if you choose to use another service. With each package you receive a gift, which can be picked up at your consultation.
- * There is a \$40 charge for makeup applied on the day of the wedding for brides. All Mothers of the bride are free! Fee is waived if the basic or pro look is purchased. Any attendants may have their makeup applied for \$25. Since there is only ONE person applying the makeup on the day of the wedding, there must be at least a two to four week notice of the number of ladies that will be having this service done. Please allow thirty minutes for makeup application for the bride, and twenty minutes for each additional ladies. Due to time constraints, any last minute requests for makeup application cannot be honored. In order for everyone to look their best, it will be necessary for me to have a brief consultation with each of the ladies either in person, by phone, or e-mail, to better assess their makeup needs.

- * All Brides may purchase their Custom Bridal Look for \$99. This includes a compact filled with three eye colors, cheek color, eyeliner, lip liner, waterproof mascara, lipstick and lip gloss. The Pro Bridal Look is \$150, and includes all of the above plus a bronzer, highlighter, and pressed powder in a large compact. The Touch Up 'N' Go Basic Necessities is \$45, and is a compact filled with a pressed face powder, a brush applicator and lip gloss.
